AGENCY DESIGNATED FUND

Nonprofit organizations have the option to establish an Agency Designated Fund through the PACF that provides the organization permanent funding and flexibilty with the use of thier fund. Agency Designated Funds allow their assigned nonprofit organization the ability to recommend grants from their fund at any time to assist with the fulfillment of your organization's mission.

How it works

- We assist in the development of a fund agreement, which establishes the Fund, the purpose of the fund, the fund's distribution criteria, and the name of the fund.
- Your organization makes a gift to the Parkersburg Area Community
 Foundation you can give cash, appreciated stocks, CDs, real estate, or other
 assets.
- You receive tax benefits in the year your gift is made.
- Your organization recommends grant support from the fund to help support its mission maintaining a minimum fund balance of at least \$10,000.
- We handle all the administrative details and provide your organization with quarterly fund statements.
- Once the fund has reached the minimum fund balance, it will continue to be invested over time. Earnings are used to make distributions to your organization to help you continue to serve your mission in our community.

More benefits

Establishing an Agency Designated Fund at the PACF is a simple and efficient way to build an endowment and flexible spending fund for your nonprofit. We handle the investment management and administrative responsibilities related to endowment so that your organization's staff and volunteer hours can concentrate on fulfilling your mission.

The community foundation's economies of scale provide your organization the benefits of a diverse investment portfolio and low investment fees that typically come only with very large funds.

Your donors can make a gift to this type of fund just like they would any other charitable fund and recieve the greatest tax benefits available! The PACF can facilitate even the most complex gifts to help build your support fund.

Agency Designated Fund Requirements

Amount to Establish: \$2,000 non-endowed; \$10,000 endowed

(Must achieve endowment within 5 years)

Fees: When your fund has reached endowment,

1.0% per year on first \$500,000

.5% per year on portion \$500,000 - \$1 million .25% per year on portion \$1 million - \$3 million Flat rate fee available per year on \$3 million+

Minimum annual fee: \$200

Fees allow the PACF to implement important community initiatives to solve regional issues and continue to serve our community.
