A STORY ABOUT COmmunity

Margaret Mead once said, "Never doubt that a small group of thoughtful, committed citizens can change the world; indeed, it's the only thing that ever has."

Thoughtful, committed residents from throughout the Parkersburg Area Community Foundation's service area have been changing the world – one community at a time – through the work of the PACF's regional affiliates. Organizing an affiliate enables communities to partner with the Foundation so that together, we can engage local citizens in making a lasting impact on the places we call home.

In 1999, a group of Ritchie County citizens partnered with the Foundation to launch our first affiliate – the Ritchie County Community Foundation (RCCF). Later that year, the Doddridge County Community Foundation (DCCF) was initiated, followed five years later by the Little Kanawha Area Community Foundation (LKACF), serving Wirt, Calhoun, and Gilmer counties.

"By working together, we can accomplish so much more than we could alone," said Judy Sjostedt, Executive Director. "The affiliate model allows local citizens to stay focused on building funds and supporting charitable projects that benefit their local communities while receiving access to the support, staffing, and resources they need centrally. It's a win-win for our region's donors as by sharing administration, we can all operate much more efficiently."

While each regional affiliate is deeply rooted locally, it is also committed to working broadly for the betterment of our shared region. Affiliate leaders work to engage those individuals, families, and business owners who care deeply about their communities and who are willing to help build a legacy for them. Many affiliate community residents are making a big difference in our area.

From the time that Ira M. Haught moved to Ritchie County in 1902, the Haught family has been deeply rooted in its county. Ira built a family business in the oil and gas industry, which later grew under the leadership of his son, Glenn, and his three grandsons, Eldon, Warren, and Alan. The company is now in the capable hands of Warren's grandsons. Over the years, Haught family members have given their time and talents generously in service to others – from Eldon's statewide community development work to Alan's longtime leadership as Ritchie County Community Foundation's advisory board chair. With Warren's leadership, the family recently created the Haught Family Scholarship with the RCCF to continue the family's legacy of support and commitment to Ritchie County.

"Through the Haught family scholarship, and other funds created or supported by family members at the Foundation, the deep roots that they have planted help to ensure that Ritchie County can continue to grow and thrive in the future," said Sjostedt. "What a wonderful legacy to create for one's family!"

Like the Haughts, many people across the Foundation's service area care deeply about their communities and want to give back to the places that have given them so much. The Doddridge, Little Kanawha Area, and Ritchie County Community Foundations – in partnership with the Parkersburg Area Community Foundation – are here to help those individuals turn their dreams for their communities into reality.

A STORY ABOUT RECOVERY

Amidst the national opioid and substance use disorder crisis, Huntington, WV, often made headlines for the many challenges its community faced, including some of the highest overdose rates in the U.S. Today, Huntington is making headlines again – but this time for its successful progress and pioneering recovery programs. Huntington Fire Chief Jan Rader shared the news of her community's initiatives at the PACF's 2019 Annual Meeting. Rader's passion and commitment to helping those in the Huntington area – including individuals with substance use disorder and the first responders who care for them in crisis – inspired the PACF, and our community, to action.

"Huntington's example of leadership and innovation motivated the PACF to consider what role we could play in bringing our community together to address this issue in the Mid-Ohio Valley region," said PACF Board Chair Cynthia Brown. "We are partnering with other local foundations and organizations to explore the ways in which we can all work together to offer leadership and resources to collectively address our concerns. The PACF also created the *Fund for Recovery* from which grants can be made to support programs that encourage prevention, support treatment and foster re-entry to society. This Fund also delivers resources to help meet the needs of persons such as children or grandparents whose lives have been affected by the substance use of family members."

The PACF has devoted a variety of resources to address this issue, including a \$5,000 grant to the Fourth Circuit Public Defender Corporation to provide safe, effective transportation to clients with substance use disorder to enable them to seek treatment.

"I had no will, no ride, and no family or friends who were willing to help." said one client. "Thanks to the Fourth Circuit Public Defender Corporation, I was able to get a bed in treatment and was transported to and completed a six-month treatment program. I graduated from the program and am now back in the community doing well."

In addition, a \$12,750 PACF grant to the Mid-Ohio Valley Drug Court supplied dentures for drug court graduates made possible by a number of chartiable funds of the Foundation.

Patrice Pooler, Executive Director of the Mid-Ohio Valley Fellowship Home speaks about the work that they are doing in the region to address substance use disorder and to assist individuals who are working through recovery.

The Mid-Ohio Valley Fellowship Home was awarded a \$9,750 grant in April 2019 to replace bedroom furnishings in the organization's men's and women's facilities.

This grant was made possible by the Dennis and Ruby Farley Memorial Fund and the Curtis and Ginger Miller Donor Advised Fund.



"Poor dental health is an unfortunate side effect of drug use. It is exceptionally difficult to find work with a felony. Imagine adding to that the challenge of finding employment with rotten or missing teeth," said Kat Boggs, Drug Court Probation Officer. "While we can give drug court participants all the tools to remain clean and sober for a lifetime, we do not have the funds to erase the physical cost of their substance use disorder. Those we have been able to aid in obtaining dentures have had amazing transformations, not only physically, but mentally and emotionally. The increase in their self-esteem is priceless."

One recipient expressed his gratitude for his new dentures, "It was the best thing that has ever happened to me," he said. "It feels good to be able to smile with how I'm living my life today! True happiness!"

Since the 2019 Annual Meeting, the PACF has helped to convene community organizations and joined with other partners to learn more about services currently offered locally and gaps to be addressed.

"Our community is beginning to mobilize," said Cynthia Brown, "and we are committed to helping provide the leadership needed to bring everyone to the table to begin to find new solutions to these critical issues here at home."


Though they passed away more than 30 and 15 years ago respectively, the story of Walter E. and Marie Ausenheimer's legacy is one that continues. The Ausenheimers are accomplishing incredible things for the betterment of communities throughout the PACF's service region through the annual grantmaking of The Walter E. and Marie Ausenheimer Memorial Fund, The Walter E. Ausenheimer Fund and the Marie Ausenheimer Fund for Senior Arts.

The largest of the three funds, the Walter E. and Marie Ausenheimer Memorial Fund was created through a bequest from the estate of Marie Ausenheimer. Since its 2004 founding, the couple's Fund has awarded nearly \$2 million to meet our area's needs and opportunities.

"This Fund has great impact due to its flexibility," said Marian Clowes, PACF Associate Director for Community Leadership. "The Ausenheimers wisely recognized that communities and their priorities will change over time so they made an unrestricted gift, enabling the Foundation to respond to our area's most pressing issues as they arise."

Recent grants from the Walter E. and Marie Ausenheimer Memorial Fund were made to help programs that assist grandparents who are raising their grandchildren; to provide training for adults seeking local employment as operators and mechanics at area manufacturing facilities, and to fund efforts to recruit volunteers to support for families and individuals whose lives are impacted by Alzheimer's disease.

Born in Bucyrus, Ohio, Walter E. Ausenheimer was the son of the late August W. and Louise Marz Ausenheimer. He graduated from Bucyrus High School and subsequently earned his Bachelor's degree from Ohio University. Before moving to Parkersburg, Mr. Ausenheimer served as controller for the McBee Co. of Athens, OH, in other executive positions for the Royal McBee Corp. of NY, and as controller for Walker Bros. in Conshohocken, PA. He arrived in Parkersburg in 1964 as the first president of the newlycreated Walker-Parkersburg Division of the Textron Corporation after Textron purchased the Parkersburg Rig and Reel Company.



Upon his retirement, Mr. Ausenheimer served his community as Camden Clark Memorial Hospital Board of Trustees Chair and as volunteer Executive Director of the Parkersburg Area Community Foundation. He also completed two assignments for the International Executive Service Corps. in the Philippines and in Thailand. Mr. Ausenheimer was a U.S. Navy veteran of World War II.

Marie Ausenheimer was born in Albany, Ohio, and also graduated from Ohio University. Upon moving to Parkersburg with her husband, Walter, in 1964, she and Walter joined the First Presbyterian Church. Over the years, Marie was active in the Parkersburg Women's Club, the American Association of University Women and Chapter L of the P.E.O. Sisterhood. She was a faithful volunteer of many years for St. Joseph's Hospital and enjoyed reading and playing bridge.

The Ausenheimer's legacy of service and caring for others in their community will be a story of commitment that continues for all times in communities across the Mid-Ohio Valley because of their foresight in making a planned gift to the PACF.



Funding from the Walter E. and Marie Ausenheimer Memorial Fund has regularly supported the Foundation's Civic Leaders Fellowship Program (CLFP). The CLFP offers local students the chance to return to their home communities to work in a career-related field while learning about their hometowns. Students are able to develop connections and leadership skills that may later assist them in finding meaningful employment upon graduation.

During the 2018-2019 fiscal year, 24 young people returned to the region and were placed at a work site, in a position related to their career interests, where they worked four days a week. On Mondays of each week of the Program, the Civic Leaders participated in leadership activities with other Civic Leaders designed to increase their knowledge of the region and prepare them to engage fully in service to their communities.

A STORY ABOUT growth

Steve Barnhart, Project Yoga MOV's Veterans Project Manager, can speak personally to the therapeutic benefits of yoga. A U.S. Army veteran, Barnhart said, "I started yoga because my wife's doctors wanted her to try yoga as part of her chronic illness therapy. We started at a small studio where there were never more than three or four people in class. Much to my surprise, yoga was helping me more than it was my wife. Wanting to expand my practice, I found Full Circle Yoga online.

At first, I was intimidated because I didn't look like anyone in the pictures, but once I finally went to a class, I discovered the peaceful and non-judgmental people inside. Yoga, Cheryl, and Patrick helped me deal with long-standing Post-traumatic Stress Disorder and moral injury and this support has truly made a difference in my life. Now I am advocating and helping other veterans experience the positive release that comes with yoga."

Founded in 2017 by the owners of Full Circle Yoga, Cheryl and Patrick McHugh, Project Yoga MOV's mission is to bring the therapeutic benefits of yoga to the Parkersburg area for individuals who are underserved. "Our clients are those who would not traditionally seek-out yoga," said Cheryl McHugh. "There are so many benefits of yoga, both mentally and physically, and we want to expose individuals to those benefits."

Currently, with certified and trained yoga instructors, Project Yoga MOV provides services to citizens in Wood, Pleasants, and Washington counties. Through Project Yoga MOV, the Mid-Ohio Fellowship Home, Wood County Senior Center, St. Mary's Correctional Center, Parkersburg Correctional Center, Boys and Girls Club of Parkersburg, and area schools have introduced the benefits of yoga to their clients/students. In addition, Project Yoga MOV, with the help of the Veteran's Center, has grown its programming to include introducing yoga to local veterans.

To solidify their commitment to the region, Project Yoga MOV established the Project Yoga MOV Endowment Fund with the PACF. "The Foundation has a well-respected reputation in our community and this new endowment fund will help ensure that our organization has an annual and sustainable source of funding to help us continue our mission," said Patrick McHugh.

Larry Cain is among one of the many veterans that participate in the classes offered by Project Yoga MOV.

"I am a 70-year-old Vietnam Veteran," said Cain.
"For the last 20 years, I have dealt with chronic pain
and sometimes debilitating pain. In June 2018 I
was introduced to yoga through Project Yoga MOV.
Since then my pain level has decreased and my
inner peace and flexibility that I have received from
yoga is wonderful. I would recommend yoga to
everyone."

A STORY ABOUT dedication

Courage, determination, loyalty, compassion and enthusiasm for life — according to Barbara and Larry Swanson, these were the hallmark characteristics that describe how their son, Jeff, led his life. And, those personal attributes are what the Foundation looks for today when selecting recipients of the Jeffrey R. Swanson Memorial Scholarship, created by Jeff's family and friends to continue his legacy of dedication and service to others.

Jeffrey Robert Swanson's story began March 9, 1971, upon his birth in Rochester, Michigan, to Barbara and Larry Swanson. At age three, his family moved south to Parkersburg, West Virginia. As he grew, Jeff was extremely active in recreational activities, playing baseball, football, and soccer, and performing in many school plays. Jeff loved horses and animals; he was always trying to find good homes for stray dogs that wandered into his neighborhood.

In 1984, his story encountered a major roadblock when a virus struck Jeff's heart. A year later, in desperate need of a heart transplant, Jeff made history as he became the Cleveland Clinic's youngest heart transplant recipient and the 10th recipient nationally under the age of 21.

Jeff never let the transplant slow him down. He continued to faithfully deliver the newspaper for his North Hills neighborhood customers and to excel in the role of goalie for the first Parkersburg High School soccer team. Later, Jeff was featured on Scholastic Sports America as well as in Sports Illustrated for Kids. He graduated from Parkersburg High School in 1989 and the Ohio State University in 1995 with a degree in physical education.

Jeff always pushed hard, teaching for three years in Georgetown, South Carolina, while also coaching soccer at an area high school and serving as a lifeguard. He was actively involved in organ donation programs across the country and he spoke to many organizations on the importance of organ donation and the success of transplantation. Jeff fully appreciated his "second chance at life" and dedicated himself

to serving as an inspiration for others awaiting transplants. In addition, Jeff competed in many National Kidney Foundation Transplant Olympic Games, focusing on swimming, running, and slalom skiing. His family proudly recalls that he was named "most outstanding male athlete" in Aspen, Colorado, during the 1995 Transplant Winter Olympics.

Jeff was living in Myrtle Beach, South Carolina, with his wife, Lynne, and three-year old daughter, Paige, and preparing for a second heart transplant at the time that he passed away on November 18, 2002.

Jeff's special life will be forever remembered through the Jeffrey R. Swanson Memorial Scholarship, a lasting legacy initiated by his family and friends to support young people in the community. Since its 2003 founding, this important memorial fund has provided educational aid to 14 graduating high school seniors from Parkersburg High School in Jeff's name.

This \$8,000 grant was made possible by four charitable funds of the Foundation, including the Jean H. Stephens Charitable Fund.

This Fund was was established in 1999 in memory of Jean H. Stephens, who passed away in 1998. This fund is to be used for the purpose of supporting charitable organizations and projects related to improving the quality of life, education, and/or other needs benefiting young women in the Foundation's service region.

Our Affiliates' growts

The Foundation's regional affiliates seek grant requests through the Community Action Grants Program. The requests are reviewed by the local Affiliate Advisory Boards and their requests for grant support are sent to the PACF's Board of Directors for official review and approval.
