


You can make your gift today or make a gift later through your estate plans.

STEP 3: Choose where your gift will be directed.



CONNECTING DURING A PANDEMIC

The impact of the COVID-19 pandemic on our community was widespread and deep, far beyond the ability of any one local funder to tackle on its own. When the PACF launched its COVID-19 relief efforts in March 2020, many partners stepped forward with funds and support, including the EQT Foundation, the Mary M. Welch Advised Fund of the PACF, Philanthropy West Virginia, Truist, Solvay, Star Plastics, and the Sisters Health Foundation. These combined efforts enabled the PACF to award grants totaling more than \$350,000 to address food access, health needs, individual financial hardship, and the continuation of essential human services.

The PACF and the Sisters Health Foundation (SHF) have a long history of collaborating in response to community needs; this partnership has been strengthened through joint efforts to provide COVID-19

relief grants to area nonprofits. Grants to the PACF Safety Net Fund from the SHF totaling \$115,000, matched by an equal amount of funds raised by the PACF, supplied vital support to food pantries and home meal delivery programs, senior centers, and nonprofit organizations delivering critical community services.

Of particular concern to both the SHF and the PACF was the impact of COVID-19 on individuals with substance use disorders and the increase in overdose rates seen in the early months of the pandemic. response, a \$10,000 grant from the PACF and SHF to the Mid-Ohio Valley Fellowship Home allowed the purchase of food, cleaning products, and personal protective equipment to ensure that its residents remained in recovery; a \$4,200 grant to Recovery Point bought hygiene items for residents and cleaning supplies and services for its Parkersburg facility; and \$10,000 allowed Westbrook to purchase Naloxone for distribution through area Quick Response Teams, which provide follow-up services to individuals who have experienced an overdose with the goal of helping them to seek treatment.




For the past three years, Circles has offered a summer gardening program to enable families to become more self-sufficient and to easily access healthy foods. This summer, Circles was concerned about continuing the program due to loss of organizational revenue. The operating support grant from the PACF and SHF helped Circles to continue, and even expand, the gardening project.

"It means a lot to us that people in the community care about us and want to help us get better," said one Recovery Point resident. "Recovery Point saved my life and the grant helped make sure that I had simple but necessary items like soap, shampoo, and toothpaste. It may not seem like much, but it's everything to me."

The Circles Campaign of the Mid-Ohio Valley received a \$5,000 operating grant from the PACF and SHF that enabled them to continue to offer services to program participants, called Circles leaders. The Circles Campaign inspires and equips families in their efforts to transition out of poverty. Circles leaders attend weekly meetings and are paired with "Allies" who serve as mentors to work on goal setting, improving financial literacy, building healthy relationships, pursuing education, and developing employment skills. Circles Campaign director Lisa Doyle-Parsons reported that "COVID-19 created a huge challenge; adaptation and prioritization was critical in maintaining a sense of connectedness in our Circles community."

The Circles Campaign typically offers a summer gardening program so that families may become more self-sufficient and easily access healthy foods. This past summer, Circles Campaign was concerned that it might not be able to offer this program due to loss of organizational revenue. The grant from the PACF and SHF helped Circles Campaign to continue and expand the gardening project.

"The regular contact with my Circles family has been a real lifeline during this pandemic," said one Circles Campaign leader. "The uncertainty caused by COVID-19 has been such a source of anxiety and stress for me and my whole family. The garden project has been so much fun and is something we can do together as a family."



THE POWER OF GIVING ONLINE

When the PACF first launched Give Local MOV in 2014, little did it realize how important the ability for local citizens to be able to swiftly and securely make donations to support their favorite nonprofit causes online would become amidst the pandemic. In May of 2020, as COVID-19 spread and caused numerous cancellations of the long-planned fundraising events of nonprofit and civic groups throughout the PACF's service area, the Foundation's annual Give Local MOV campaign took on even greater meaning. For many groups, it became their sole source of spring fundraising resources.

Since its inception, this virtual giving event has raised more than \$1.5 million with community interest growing each year. While Give Local MOV began 8 years ago as a way of celebrating the 100th anniversary of the creation of the nation's first community foundation, it has come to symbolize a way for our community's foundation, our region's nonprofits, and our donors to work together to increase the resources available to address our common good.

Philanthropy WV, a state-wide philanthropic organization, presented a special late-breaking challenge to the PACF in the days leading up to Give Local MOV 2020 as part of its own "Take Five to Give Five" campaign. Through the challenge Philanthropy WV would match donations made to the PACF's COVID-19 relief funds made during the online day of giving. By "piggy-backing" on the Give Local MOV campaign, the PACF raised \$46,255 in COVID-19 relief funding of which 100% was swiftly distributed to relieve local hunger and emergency needs through grants to local nonprofits serving area residents.

"We had an extraordinary 24-hours in the Mid-Ohio Valley," said Julie Posey, PACF's Development and Communications Officer. "On behalf of the participating organizations this year, the PACF wishes to express its profound gratitude to everyone who supported this year's outstanding Give Local MOV campaign. We're truly humbled and inspired by the outstanding generosity of so many people. To

have a record-breaking event during a pandemic is just

awesome."

A key benefit of giving to the participating nonprofits on May 5 was the availability of 1:1 matching funds and incentive prizes. Several regional sponsors, led by Superior Toyota and Williamstown Bank, supplied matching funds that made the day even more exciting.

"We're so thankful for our community and want to give back," said T.R. Hathaway, Owner of Superior Toyota. "Give Local MOV is an excellent way to do just that in our community."

The next event is set for May 4, 2021.

Habitat for Humanity of the Mid-Ohio Valley participated in Give Local MOV 2020 with the goal of raising funds for its 106th house. Through the campaign, more than \$7,500 was raised to help build a new home in Williamstown, WV for the Davis family.



CONNECTING SENIORS TO LIFELINES

According to the National Council on Aging, providing access to healthy meals is vital to keeping older adults healthy and out of the hospital and away from situations that might increase their risk of contracting COVID-19. More than 84% of persons aged 65-plus have at least one chronic condition and face economic hardship, making food insecurity an issue of great concern.

Many senior citizens throughout the PACF's service area already struggle to make ends meet. Social Security is often their sole source of retirement income. Given the ongoing impact of substance use disorders locally, numerous grandparents are raising grandchildren, having to make their fixed retirement incomes spread even more thinly.

The arrival of COVID-19 worsened already difficult circumstances as older adults in poor health or lacking transportation often had difficulty accessing a grocery store or other food resource. Senior centers, churches, and civic groups became lifelines and devised creative ways to provide and deliver food and supplies to their clientele.

The PACF's staff reached out proactively and repeatedly to senior citizens' organizations across the Foundation's 11-county footprint. Grant funds provided more than 13,400 meals to 400 Wood County seniors. In neighboring Wirt County, grant resources supported the senior nutrition program and purchased personal protective equipment. One senior citizen reported to the PACF, "Because of my health issues, I have been very afraid during this pandemic, and at times, have panicked about being around other people and going out of my home. With the help of the senior center, I have protective coverings and I know that they will help me if I need it."

Additional seniors in Calhoun, Gilmer, and Roane counties were among those aided by Foundation grants. Along with the resources, it was clear that the assurance of support for the region's senior centers also brought hope to their clients. One Calhoun County client who is legally blind said, "I am always happy to see my delivery driver and get my meal. That's how I know for sure that this old world is still turning and everything's okay for another day."



With the help of a \$4,500 grant from the Smoot-Widmeyer Fund, Coplin Health Systems partnered with WVU Extension Services and Rural Action this summer to provide fresh produce to patients in Elizabeth, WV through the "Farmacy" program. The goal of the project was to educate patients on the importance of eating healthy foods to help with chronic disease management. Patients were given a "prescription" voucher that they could redeem for fresh produce at the Farmacy. The project served 105 patients, and many experienced positive changes in health indicators, including reduced blood pressure and weight loss.

"This program has not only helped me with eating healthier, but it has been a lot of fun for our family," said one patient. "Since we don't know what we will be getting each week, my kids take on the bag of vegetables like their own personal "Chopped" challenge, like you see on TV. So far, they've made hasselback potatoes, eggplant parmesan, and stuffed peppers. I love that this program has helped me lose weight, eat smarter, and have fun!"

CONNECTING TO COMMUNITY

The first in his family to graduate from college, Michael Hick's passion for public service led him to the Civic Leaders Fellowship Program of the PACF during the years in which he was working toward his Bachelor of Science degree in Agricultural and Extension Education, with a minor in agribusiness management and rural economic development from WVU.

In his 2014 application to become a PACF Civic Leader, Michael indicated, "From a young age, my parents taught me the importance of hard work and in believing that you can achieve anything that you set your mind to." Describing the type of community in which he wanted to reside someday, Michael wrote, "Once I complete college, I would like to live in a rural community that has active and caring members. It would be ideal if agriculture was an important community industry. That description accurately describes Arnoldsburg, my hometown in Calhoun County. Upon graduation I would be grateful if I was fortunate enough to return to Calhoun County." And, when asked why he should be chosen for the Civic Leaders opportunity, he replied that if selected, "I would try to impact lives in a positive way."


As a first year Civic Leader assigned to the Calhoun County Extension Office, and later for his second and third years as a Fellow in the Calhoun County Prosecuting Attorney's Office, Michael was able to spend his summers deeply immersed in learning more about the workings of the agricultural and legal fields in his home community and networking with others in state and local leadership roles.

In 2016, he chose to run for the office of Calhoun County Commissioner. In a Hur Herald interview, Michael said, "Calhoun County has always been my home, and I'll work tirelessly to make sure the next generation can say the same." His efforts to make a difference by becoming elected were rewarded as he successfully unseated an incumbent, winning election to the Calhoun County Commission.

After graduating with high honors from WVU in 2017, through connections he forged, he participated in Leadership West Virginia, and next opted to pursue a legal career.

Fast forward to 2020, Michael was awarded his Juris Doctorate (JD) from the WVU School of Law and is well on his way to fulfilling many of his life goals.


Michael now works as in-house legal counsel and corporate compliance officer for the



Minnie Hamilton Health System, an organization on the frontlines of delivering essential COVID-19 relief in his home community as a rural health system that includes a critical access hospital, Federally Qualified Health Center, rural health clinic, dental clinic, and long-term care.

Celebrating marriage in 2020 to his best friend and wife, Samantha, the couple is renovating their home, living in Arnoldsburg, near where Michael grew up. He was recently appointed to the Advisory Board for the Little Kanawha Area Community Foundation, affiliate of the PACF. As his parents said, his hard work and focus on his goals have placed him right where he always wanted to be -- home in Calhoun County.

The Civic Leaders Fellowship Program is about helping our region to retain its educated young people and encouraging them in their efforts to build a stronger future for our hometowns. Congratulations on modeling the way for others, Michael!



The Civic Leaders Fellowship Program offers local students the chance to return to their home communities to work in a career-related field while learning about their hometowns. Students are able to develop connections and leadership skills that may later assist them in finding meaningful employment upon graduation.

During the 2019-2020 fiscal year, 22 young people returned to the region and were placed at a work site in a position related to their career interests for seven weeks. The first week of the Program allowed participants to participate in online leadership activities with other Civic Leaders designed to increase their knowledge of the region and prepare them to engage fully in service to their communities.

A recent study by Ohio University's Voinivich School researchers indicates that this Program returns \$32.77 in value for every \$1 invested in supporting it. Learn more at www.pacfwv.com/clfp.

ENSURING EVERYONE IS CONNECTED

With the implementation of Stay-at-Home orders and other restrictions put into place in March, many area residents lost their employment. People with disabilities were among those who were adversely impacted and many clients of SW Resources (SWR), a regional supported-work environment workshop, were unable to continue working as the pandemic hit.

According to Lewis Newberry, SWR's director of development, the resulting lack of income made an already challenging time even more daunting for their clients to navigate. "After working with one of our disabled clients for several months, we were able to help him to locate an apartment to move into, moving out of a residential facility. He was working in our warehouse facility full-time, receiving training on life skills to enable him to live independently. Showing success with all of this, he was excited to get his apartment and begin a new life, while still working at SW Resources. Part of his residential plan involved training him in paying bills like rent and utilities. Just a couple of weeks after transitioning to an apartment, COVID-19 hit, and he could no longer come in to work because of program restrictions. This caused him extreme anxiety—he felt like he was going to lose everything and didn't understand how he could pay the bills."

The PACF learned of this situation and responded with two grants to SWR, totaling \$15,000. With part of the PACF's funds, clients who were restricted from working at the facility, and who were ineligible for unemployment benefits, received assistance with rent and utility payments. With these funds Newberry said, "We were able to provide this client with the resources to stay in his apartment

and to pay his electric bill for two months until he could return to work. These funds not only guaranteed he could stay in his new apartment but also that he could continue his independent learning experience by paying bills on his own for the first time." In all, 29 Wood County SWR clients were assisted.

Another portion of the PACF grant supported SWR's operations. Like many area nonprofits this year, SWR was forced to abandon its 2020 fundraising events resulting in nearly \$60,000 in lost revenue for its mission at the very point in time when its support was most needed by clients. From May through August, SWR's workload increased dramatically in their warehouse operations due to contracts deemed essential for products to be shipped. Consequently, SWR expanded warehouse capacity, installed workplace partitions, added hand sanitation stations, and improved airflow circulation. The PACF's grant helped to keep essential staff safe by purchasing personal protective equipment and supporting this expansion.


"Without the PACF funding, SWR would not have been able to effectively respond to the impact of COVID on the communities we serve," said Newberry.

A \$2,000 PACF grant from the Mid-Ohio Valley Endowment for Women, Children, and Families helped purchase items for the Gilmer County FRN's Teen Holiday Shoe Box Program. The FRN reports that one of the families that picked up the shoe box was a grandmother raising her granddaughters. Without the program, she would not have been able to provide a gift for her oldest granddaughter for the holidays.



Lack of access to oral health care is a significant problem in our region. Thanks to an expanded dental clinic at Health Access, uninsured or under-insured Doddridge County residents will now have better access to care. A \$4,500 grant from the Doddridge County Medical Center Charitable Fund and the Walter E. and Marie Ausenheimer Memorial Fund enabled Health Access to purchase necessary supplies to outfit the new dental units. In recent years the clinic has served more than 750 Doddridge County residents, 21 of whom have been served since the new dental unit opened earlier this

"Not only has accessing dental health care been difficult as a result of not having dental health insurance, but I've also been incredibly apprehensive about going to the dentist for most of my life," said one patient. "The dental team at Health Access went above and beyond to ease my fears and really did an outstanding job."






