# FINANCIAL SECURITY BRINGS HOPE

hardships that have the potential to affect the entire community. With its proven counseling and education programs, CCCS helped 1,998 individuals in 2020.

Shrewsberry said, “I’m encouraged when I see our community working together around a common goal, gaining strength and resilience even when faced with the toughest of situations, like the pandemic, because we’re supporting each other.” CCCS recently launched financial education and training programs to assist individuals with substance user disorders (SUD), in partnership with other local treatment and recovery programs. “I’m hopeful about our efforts around SUD, where we are working collaboratively to help persons suffering from SUD to overcome the root issues of misuse and to deal with potentially triggering situations. CCCS holds an important role, helping SUD clients to overcome financial barriers that might otherwise overwhelm them as they engage in recovery.”

Shrewsberry added that the PACF is an important partner in her work. “Along with its generous grants, the connections fostered by PACF for us to other nonprofits, small businesses, corporations, and civic leaders, are priceless in providing hope to CCCS and our clients.”

Studies show that nearly one third of people have few resources set aside to cover personal emergencies. When the unexpected happens, such as a job loss from a global pandemic, unplanned bills can add up and cause people to pursue emergency borrowing in the form of credit card charges or the use of highly expensive forms of credit like “pay day loans” to acquire quick cash.

COVID-19 made already precarious financial situations even worse for many local families and caused financial instability for the first-time for others who had not previously experienced it. At challenging times like this, the key to finding the hope to overcome life’s obstacles, according to Shelene Shrewsberry, Consumer Credit Counseling Services (CCCS) Executive Director, is to “never give up!”

For forty years, CCCS’ mission has been to provide solutions to the “financial problems facing today’s family.” This philosophy broadened over the years to include helping families avoid and overcome financial



*CCCS shared a key board member with the PACF, Bruce Holmes. # GIVING INSPIRES HOPE

The PACF exists because of the generosity of many good people, present and past, concerned about improving our region, who willingly give to help others. Each person we work with has a unique vision and a personal purpose to his or her charitable giving. The Foundation is here to serve as your partner; to assist you in crafting your own charitable goals, and to help you make a lasting difference in your community.

## How to Give

### STEP 1: Decide when you want to make your gift.

You can make your gift today or make a gift later through your estate plans.

### STEP 2: Identify what you want to give.

#### Give Now

**Cash:** Gifts can be in the form of cash or check.

**Stocks, Bonds, and Mutual Funds:** Long-term appreciated holdings often have better tax advantages than gifts of cash. When you gift publicly traded stock, you can receive full market value for the gift and avoid capital gains tax.

**Real Estate:** The PACF can accept real estate gifts outright or work with you to establish a Charitable Remainder Trust.

**Convert a Private Foundation:** Allow the PACF to manage all the administrative details while you and your family focus more on the grantmaking. Transferring your private foundation to the PACF allows you to stay engaged with your giving and receive community foundation benefits.

**Gift from IRA:** If you are 70.5 or older, the Charitable IRA Act allows you to make a gift of up to \$100,000 directly from your IRA for certain charitable purposes.

#### Give Later

**Charitable Bequest:** Give a gift through your will or trust to the PACF. Such gifts may enable you to make significant contributions beyond those possible during your lifetime.

**Life Insurance:** Life insurance offers a simple way for you to give a significant gift with tax benefits that you can enjoy during your lifetime. When life insurance is no longer needed, consider a gift by either giving a paid-up policy or by continuing to pay premiums.

**Charitable Remainder Trust:** You transfer assets into a trust and the trust pays regular income payments to you or a beneficiary whom you designate. Upon the beneficiary's death or after a defined period of years, the remaining assets in the trust transfer to the PACF for the charitable causes you stipulate.

**IRA or Retirement Plan Assets:** Name the PACF as a beneficiary of all or a portion of your IRA, 401(k), or other qualified plan by completing a beneficiary designation form through your plan administrator.

### STEP 3: Choose where your gift will be directed.

Wood County Society (WCS) believes that having equal opportunity is a human right and that life’s best experiences should be available to everyone. With its therapeutic programs, the Artbeat Studio, the Autism Connection Center, literacy and education initiatives, and its respite care initiatives, WCS sees hope in abundance through the experiences of their families and consumers.

“Our organization’s collective hope has grown as we’ve successfully navigated COVID-19 together and see that our mission continues to have a deeper, more strategic impact daily,” said WCS Executive Director Brandon Gress. “We stand united in understanding that each member of our community is a difference-

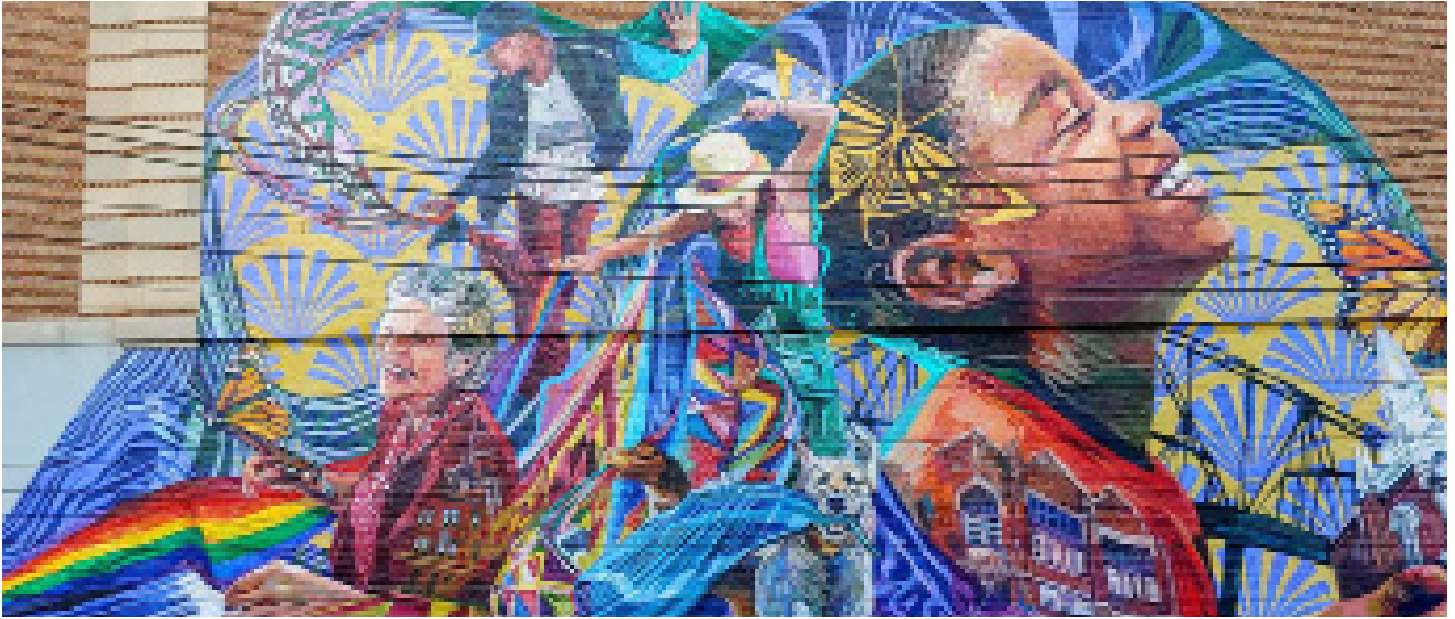
maker, an advocate, and a collaborator. Cultivating hope and a positive environment starts with knowing that embracing our own uniqueness and contributions – each individual passion, voice, and heartbeat – together holds great potential to improve our community.”

Launched just prior to the pandemic, Wood County Society’s newest initiative, the Artbeat Studio, provides an opportunity for talented artists with developmental differences to create artistic masterpieces from “up-cycled” materials. Despite challenges over the past year, the Studio is thriving, with artwork produced at the Studio now on display throughout downtown Parkersburg and for sale through the Art from the Heart Shop. The PACF supported the Artbeat Studio with operating support grants to help it launch and with technical assistance from its Social Enterprise Ecosystem (SEE) grant.



Gress said, “The PACF and its donors are a beacon of hope in our region; they inspire compassion by encouraging accessibility and inclusion across the Mid-Ohio Valley. Our collaboration with PACF builds a strong foundation for our organization’s mission, vision, and core values. The PACF empowers and progressively acts as an advocate to ensure the strength and sustainability of our Mid-Ohio Valley community of nonprofits.”

# ART THAT HEALS GIVES HOPE

All of our community’s children are worthy and deserving of a stable home life situation. Yet every year, many foster children in our community “age out” of the official care system, leaving them with an uncertain path ahead and a future that too often involves joblessness and homelessness. The WV Children’s Home Society’s Transitional Living Program helps young adults aged 16-22 to work toward successful transition to independence and adulthood.

Jessie Siefert of the Parkersburg Art Center said, “We did a workshop with the youth who take part in the WV Children’s Home Society (CHS)’ Transitional Living Program. These youth are having to save themselves; to find the strength and resources they need to live their adult lives. Many have been in and out of foster care and haven’t experienced what a ‘traditional’ or ‘stable’ home life feels like. Once they find the CHS program, Michelle and the other staff teach life skills and offer housing aid, educational help and job assistance. The caring CHS staff recognize the importance of the arts—how art is a healing means of self-expression—so they secured

art materials to enable their youth to create works of art. They also asked us to offer a 3-D art workshop to introduce new materials and new ways of thinking about their art. A gallery exhibit and a reception was held for the youth, showcasing their art work. You could feel the sense of accomplishment in the room.”

Siefert said, “Various funds from the Parkersburg Area Community Foundation (PACF) have given us hope over the years by enabling us to reach out to communities that might not otherwise have the opportunity to visit the Art Center or who just need an extra welcome. One example is the Ruth M. Tepley Memorial Fund of PACF. While modest in size, it’s big in impact. With its funding, we supplied an art instructor for Jefferson Elementary’s after-school program, providing the opportunity for those kids to receive a quality arts education. Jefferson is a school in a low-wealth area. Money should not limit opportunities for kids, but often does. PACF’s grants help to reduce that opportunity gap.”

She continued, “I think we’ve learned from the pandemic that we truly are better together.

Collaboration and a sharing of resources and ideas is the key to cultivating a more hopeful and positive environment. It should not be about us ‘having this stick’ and you ‘having that stone,’ it needs to be about each of us sharing our materials to build something bigger and better than any organization could build on its own. Our hope as the region’s art center is that we are able to open our arms wider to embrace more people who need the mind/body/soul connection that art can provide.”

## FOUNDATION SUPPORTS ARTS PROGRAMS AMID PANDEMIC

Wood County’s arts and culture sector continues to feel the effects of the COVID-19 pandemic. Area agencies and artists have had to cope with cancellations of shows and closure of venues which places financial strain on organizational operations.

While some organizations received access to federal CARES act loans and grants to help them through this challenging time, more support is needed to

ensure that these critical community organizations remain sustainable. The PACF recognizes the importance of investing in our community’s arts and cultural resources as they hold a major role in community development and tourism, personal and community enrichment, and individual well-being. Several arts organizations are anchor institutions for downtown Parkersburg development and revitalization.



The Foundation reached out to Wood County’s arts and culture community to identify needs and opportunities during the COVID-19 pandemic. Aided by participants in its Civic Leaders Fellowship Program, each organization’s needs were reviewed and grants awarded to four area agencies: West Virginia Symphony Orchestra – Parkersburg, Smoot Theatre, Artsbridge (pictured left), Parkersburg Art Center, and Actors Guild of Parkersburg. These grants provided needed and immediate assistance to help each of the organizations during this unprecedented time.

# BEING PRESENT OFFERS HOPE

Founded in 2000, the Calhoun County Family Resource Network (FRN) is known for its leadership in responding to needs and coordinating services in the county. According to Tina Persinger, FRN Director, “We have so many encouraging developments in Calhoun County right now that are helping to build hope and pride in the County!”

At the beginning of the COVID-19 pandemic, the FRN was the only agency open and worked hard to meet essential local needs. “We started food, hygiene and cleaning pantries for our community and continued to operate our thrift store” said Persinger. “The PACF brought us hope by offering funds to help stock our pantries. It was such a blessing and relieved our stress, knowing that we could provide for our clients’ essential needs. The support from PACF offered our clients hope as they gained confidence that they would have their most basic needs met and could move on to tackling other stressors in their lives.”

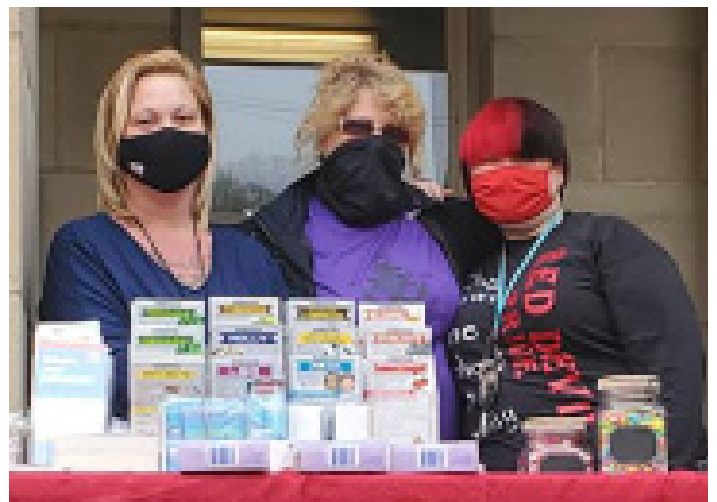
The FRN has grown significantly in the past year, securing a loan, purchasing its own building and adding four HUD approved apartments. The new facility supports the FRN’s plan to launch a “drop in” center for area residents to receive information and referrals. The FRN also expects to partner with the Calhoun County Health Department, Domestic Violence Center and Quick Recovery Team, to aid clients in securing a spot in a recovery unit or shelter, or to meet other essential needs.

“I think the Calhoun FRN gives our clients a sense of hope because we sit down and listen to their problems and try to find solutions. We listen to hear



whether we, or another community agency, can best meet their needs,” said Persinger. “We help our clients to make calls, to apply, and to do the necessary paperwork—we don’t just send them on to the next agency.”

The FRN’s work makes a difference in people’s lives. “Our clients’ successes give us hope for the future,” said Persinger. “We’ve helped individuals who are ‘down on their luck’ and actively experiencing addiction. One gentleman who we’ve helped has been in recovery for over six months! He was featured in a recovery video, having gained part-time employment and secured an apartment. He said that whenever he feels like giving up, he remembers that we care and doesn’t want to cause us to be disappointed in him. It gives us hope for him and for our community to hear of his continuing progress.”



# INCLUSION LEADS TO HOPE

Since 1955, The Arc of the Mid Ohio Valley has provided opportunities for people with disabilities to become fully immersed in their community and to lead rich and fulfilling lives.

The COVID-19 pandemic raised both new challenges – and provided new opportunities – for the Arc and the people who it serves. Executive Director Liz Ford said, “The Arc rapidly evolved to better meet the needs of people with disabilities by providing in-person and virtual training, meetings, and socialization opportunities for all. By making changes, we eliminated a long-standing barrier to participation—that of transportation. Watching those we serve move outside of their comfort zone to embrace new technologies to stay connected, gave us great hope, along with a deeper appreciation for the valuable tools and talents of our self-advocates.”

Ford noted that people whose lives are affected by disabilities are disproportionately impacted during times of high unemployment and that the pandemic’s added health risks accelerated job losses. “PACF offered hope by making connections that increased our training and employment opportunities and expanded the gift of community inclusion,” said Ford.

At the height of COVID, The Arc transformed a former beauty shop into the People First Café. Through PACF’s involvement in an Appalachian Regional Commission Power grant for the SEE program, PACF staffer Marian Clowes introduced Ford to John Glazer of Ohio University. Glazer was able to help The Arc plan for the Café. “John produced an amazing feasibility study that brought us one step closer to our goal,” said Ford “With the volunteer leadership of Della Lyons, grants from the PACF and other community funders, and volunteers from Recovery Point of Parkersburg providing labor, our project culminated in a much needed training site for people with disabilities seeking employment in the food service industry.”

Nearby Parkersburg High School students can walk to the Café to participate in pre-vocational exploration and later experience “hands-on” training, allowing them to gain confidence and successfully acquire future community employment. The People First Café will deliver additional training and employment options for adults through the Arc’s partnerships with SW Resources and Westbrook Health Services, Inc. And, the Café also provides a venue where people with disabilities may sell handmade art work, increasing their income and providing non-traditional employment. Ford said, “Putting ‘People First’ and gaining strength by collaborating with others has brought our organization and our community hope.”

The PACF’s partnership with The Arc over many years has helped to ensure that the organization has resources to maintain and expand its facilities, programs, and services. As Ford notes, “PACF helps us grow our endowment fund, giving us security in knowing that our valuable programs and services can benefit our region’s citizens in perpetuity. The Give Local MOV program matches money raised for our agency and raises awareness of our role and vital services. And we have been fortunate to have a Civic Leaders Fellow assigned to work with The Arc nearly every summer to support our programs. Through all of these services, PACF builds our organization’s capacity and hope.”



# SENSE OF BELONGING BUILDS HOPE

Each summer, the PACF’s Civic Leaders Fellowship Program offers students from our region who are pursuing post-secondary education the opportunity to secure meaningful employment related to their career goals, while participating in learning activities that nurture interest in civic engagement. Many former Civic Leaders are now living and working in the Mid-Ohio Valley (MOV), and serving their communities. Civic Leaders alumna Megan Hardway shared her thoughts on how the Civic Leaders Fellowship Program builds hope for young people.

“Growing up in the MOV, a long-standing rumor circulated that “there’s nothing here for young people.” As time passed, it became easy to assume that was true. As I grew older though, and my values changed, life became less about ‘finding something to do on the weekends’ and more about finding meaningful employment where I could grow professionally in a community where I could someday raise a family.

With those thoughts in mind, I applied to be a PACF Civic Leader. My experiences as a Fellow showed me that Parkersburg wasn’t such a bad place to achieve my goals after all. It was amazing how fast my personal and professional connections grew and how far my network expanded as I interned at my summer placements, the Chamber of Commerce of the MOV, Downtown PKB, and Marietta Main Street. Along the way, I gained valuable friendships with others who were seeking out the same things that I was. It was

exciting to take part in the positive changes happening locally that sometimes citizens don’t notice. I found a sense of hope here in my hometown that I didn’t initially have as I saw that I could stay here and create a life for myself.

Currently, that’s what I’m doing and I have so much interest in continuing to help other young people feel a sense of belonging here, too. I want to be a part of de-bunking that old rumor and making life more appealing for our next generation. I’m thrilled to see my peers thriving in leadership positions at area nonprofits and businesses, moving up within their workplaces, finding solutions to local issues and taking part in the bigger picture of life happening in the MOV. It gives me hope that the MOV will continue growing and thriving.

The support I’ve received from the PACF gave me hope for the future because they are an example of a hub from which positivity radiates. They’re doing great things and that’s contagious. It truly helps others like me want to get involved and to do the same thing.

The PACF is continuously working to solve our community’s issues. I believe the foundation’s greatest strength is its reliance on building partnerships and relationships. They know that no organization or community can do it alone. By linking and supporting so many groups, the PACF is cultivating a culture that encourages younger generations to stay in the area.”



## 2021 CIVIC LEADERS FELLOWSHIP PROGRAM

The PACF celebrated the successful completion of its tenth year of its Civic Leaders Fellowship Program. Eighteen students were placed with host employers throughout the PACF service region to gain work experience in their respective fields. Students participated in leadership training on Mondays during the program. More than 75 community members contributed their time to help the students learn about civic engagement, leadership, career options, and nonprofits organizations in our community.

“I’ve learned so much during my program,” said Zoe Pingley, a first year Civic Leader. “I’ve learned passion, leadership, art, love, hard work, dedication, and so much more. The Program was not just a ‘summer internship.’ It was an opportunity to see and love my community around me and allow me to place myself into some of the most important things it has to offer. I learned so much about my field and future career, but also so much more about myself as a person.”

During the seven-week Program, first-year Civic Leaders spent their Mondays engaging with one another, learning about the community’s needs and issues, and exploring personal and professional development opportunities. Second-year Civic Leaders spent their Mondays furthering their leadership studies, visiting area nonprofit organizations, assessing community needs, and learning about community grantmaking. The second-year Civic Leaders visited many different nonprofit organizations over summer, evaluating where to award \$5,000 in grant funds.

The following grants were awarded to area nonprofits: Old Man Rivers was awarded \$2,500 to support its food pantry. Wood County Society was awarded \$2,500 to develop an Emergency Preparedness Plan to help individuals with intellectual and developmental disabilities during a national and local emergency.

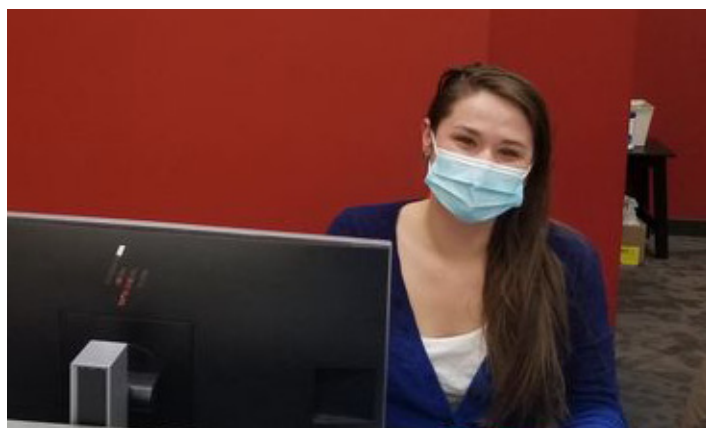
