#### More than \$528,000 Raised in 2023

#### Progress on the Ridge

The Progress Ridge Community Building was awarded \$2,500 in the PACF's fall Community Action Grant cycle for building renovations. The Progress Ridge Community Building's mission is to provide a safe and welcoming community center and to promote inclusive activities that enrich the lives of our community and support people to engage, connect, and grow in the area. This grant, made possible through the Mid Ohio Valley Endowment for Women, Children, and Families Fund at the PACF, helped to purchase and install a new ceiling and metal walls for the building. The original chipboard on the walls was starting to deteriorate and fall into pieces. The drop ceiling was coming unglued. Chipboard and insulation were coming down in the air and onto the tables. Now their members and community are safe from these health hazards.





Their Second Act is Giving Back

The Mid Ohio Valley Regional Council (MOVRC) received a Community Action Grant in the spring of 2023 for their AmeriCorps Seniors programs including the Foster Grandparent and Senior Companions programs. According to MOVRC, 57 Foster Grandparent volunteers mentored/tutored 266 students

at elementary/secondary public schools, library programs, and daycare centers in Calhoun, Gilmer, Jackson, Pleasants, Ritchie, Roane, Wirt, and Wood counties. Additionally, 14 Senior Companion volunteers served 23 clients in Calhoun, Jackson, Ritchie, Roane, and Wood counties.

#### The Rock Church Creates New Endowment Funds

"These endowment funds will continue to help ensure that future generations of students will have access to an excellent Christian education while providing long-term financial stability for the organizations." The new funds will provide a permanent source of funding for the three organizations. Investment and administrative responsibilities are handled by the PACF so that the organizations' staff and volunteers can concentrate on fulfilling their mission.

## Celebrating - 25 YEARS -



More than two decades ago, a group of concerned residents took action that led to the formation of the Ritchie County Community Foundation. Since then, many people from throughout the region have worked tirelessly to build upon their effort. What started as a single grantmaking fund in 1999 has now grown to a collection of 38 named funds dedicated to the betterment of Ritchie County. Since 2005, the RCCF has awarded nearly \$733,000 in grants and scholarships, including recent grants to support the Ritchie County Humane Society, Cairo Volunteer Fire Department, and City of Pennsboro. ## Lelebrating -20 YEARS -



Two decades ago, a group of dedicated residents took the initiative to establish the Little Kanawha Area Community Foundation. Created in 2004 to serve Wirt and Calhoun counties, the LKACF later expanded to include Gilmer County. What started as a single grantmaking fund has now grown to a collection of 18 named funds. Since 2007, the LKACF has awarded nearly \$350,000 in grants and scholarships, including recent grants to support the Gilmer County Volunteer Fire Department, Town of Grantsville, and Two Runs Community Association.
